Charge per mega watt: \$700 + cost
 Substation \$1,100 + cost
 Transmission line fee: \$1,100 pr. Mile
 Yearly inspection fee: \$400 per turbine
 Yearly inspection fee on Substations \$440.00 per substation
 Yearly inspection fee on transmission lines above and below ground \$275.00 pr mile

Alternative Energy Projects started without permits approved by Minden Township are subject to \$5000.00/day penalty.
